Sharon Crossman called the meeting to order at 6:33. She asked if there were any additions or changes to the agenda. There being none, Sharon turned the meeting over to Mark Westa, Stevens and Associates.

Mark summarized the earlier meetings by reviewing the study areas A,B,C,D,E; the flood plain and floodways, and the 3 conceptual options in consideration. He said that tonight's presentation combined and consolidated ideas from the three options into a Draft Preferred Plan. Mark explained that the logic of the design recommendation was to 1) reduce flood damage in the study area; 2) reduce traffic impacts; and 3) to consider water/wastewater infrastructure.

Mark presented the draft preferred plan, took comments and questions from the zoom participants.

The meeting adjourned at 7:58 PM.
